High potency synthetic opioids, such as fentanyl and its analogs, pose a significant public health crisis, particularly affecting families involved with child welfare courts. These powerful substances are not only highly addictive but also dangerously potent, leading to increased risks of overdose and severe health consequences. Understanding how high-potency synthetic opioids impact child welfare involved families allows court systems to better protect the safety of children while providing families with the supports and services they need to address opioid misuse. This presentation will provide essential information on the impact of these opioids on families and the role of child dependency courts in addressing these challenges.

In 2024, the Washington State Legislature passed [SB 6109](#) which requires that "the court shall give great weight to the lethality of high-potency synthetic opioids and public health guidance from the department of health related to high-potency synthetic opioids, including fentanyl..." when making removal and placement decisions. The DOH expects the guidance will change over time, as they continue to learn more about the impacts of high potency synthetic opioids on children and families. SB 6109 provided funding for additional training resources, new services, and several pilot programs.
