
COURT REPORTS: WHY ARE THEY IMPORTANT?


Why are you writing?

OBJECTIVE WRITING

YOU ARE WRITING ABOUT VISITS GOING WELL.

- Visits for Mr. Barnes are going well, and Thomas likes visiting with his dad.
- Mr. Barnes stays engaged with Thomas during visits and Thomas also seems to enjoy them. Visits are going well.
- Mr. Barnes has been visiting, three (3) times per week, for 3 hours monitored. He has not missed any visits and the visit supervisor reports no safety concerns. This advocate has reviewed all visit notes and observed four (4) visits. When Thomas arrives for the visit, he runs to his dad for a hug. During visits Mr. Barnes brings age- appropriate activities and snacks; and remains engaged with Thomas throughout the visit.

OBJECTIVE WRITING

YOU ARE WRITING ABOUT A CHILD WHO AS MOVED MULTIPLE TIMES.

- Sarah is a difficult child and has had to be moved many times this review period.
- Sarah has been unsafe in her foster homes and has been moved three (3) times this review period.

• Sarah has had to be moved three (3) times during this review period, she is now in her fourth (4th) foster home. All prior foster parents reported that Sarah punched holes in their walls, cut herself, and tried to runaway.

PERSUASIVE WRITING

YOU WANT TO RECOMMEND A PARENTING SERVICE FOR VISITS

OBJECTIVE WRITING

YOU ARE WRITING ABOUT VISITS GOING WELL

- Visits for Mr. Barnes are going well, and Thomas likes visiting with his dad.
- Mr. Barnes stays engaged with Thomas during visits and Thomas also seems to enjoy them. Visits are going well.
- Mr. Barnas has been visiting, three (3) times per week, for hours monitored. He has not missed any visits and the visit hours monitored. He has not missed any visits and the supervisor reports no safety concerns. This advocate has reviewed all visit notes and observed four (4) visits. The Thomas arrives for the visit, he runs to his dad for a hug. During visits Mr. Barnas brings age appropriate activities and stacks; and remains engaged with Thomas throughout the visit.

- Mr. Barnes should have hands on parenting during visits.
- During visits, Mr. Barnes struggles with staying engaged and should have a parenting service.
- During visits, Mr. Barnes sits on the couch while Thomas plays by himself in the corner. Mr. Barnes will call Thomas over to the couch, but Thomas does not always respond. Mr. Barnes has shared with this Advocate that he is not sure what to do with a 3- year-old. This Advocate believes a parenting coach could help Mr. Barnes engage during visits.


PERSUASIVE WRITING

YOU WANT TO RECOMMEND COUNSELING FOR A CHILD OCCUR OUTSIDE SCHOOL HOURS.

- Sarah should have counseling when she is not in school.
- Sarah is struggling and needs counseling. She should not have to miss school to attend any counseling sessions.
- Sarah has shared with this advocate that she would like to be able to talk with a counselor. Her teachers and caregivers report that she has been having a hard time regulating her emotions at home and school, often bursting into tears or slamming doors. Sarah is behind in 3 of her 6 classes, and while she struggles in her classes, she reports a supportive peer group at school. This advocate recommends that Sarah be referred for counseling, and that appointments are scheduled outside school hours.



TIPS FOR EFFECTIVE REPORTS AND RECOMMENDATIONS



KNOW YOUR AUDIENCE



There is a story behind every person. There is a reason why they are the way they are. Think about that, and respect them for who they are. - marcandangel

CONSIDER EACH CASE UNIQUELY

CHILD FOCUSED AND FAMILY CENTERED

Keep the child's best interest at the forefront.

What is the child's perspective?

Understand the family's current situation, strengths, needs, etc.

Respect a family's culture

TACT AND TONE MATTER

- Check for negative emotion
- Use clear, non-judgmental language
- Eliminate opinions; add fact
- Check for bias/personal judgments
- Accuracy matters as does delivery
- Who is reading the report- present/future

BALANCED VIEWPOINT

Strength based and trauma informed

Discuss the positive and the negative

Consider a "compliment sandwich"

"Here's some good news and here's some more good new news, but here's some bad news... therefore we need to..."

Acknowledge progress

Check for bias

Autocorrect has become my worst enema.



GRAMMAR MATTERS

Keep it simple/crisp 02

Use an active voice 03

Straight forward sentences 04

Watch your modifiers

Delete unnecessary prepositions 06

Use paragraphs and punctuation

GRAMMAR TIPS

Long Sentences v. Short sentences

- · Best for important points (SS) · Provide strong emphasis (SS)

CONNECT THE PIECES



• Recommendations should:

- Be backed up by the contents of your report.
- Match the type of hearing.
- Not be a surprise to the parties.
- Be easy to find.
- Don't move the finish line.
- Offer other possible solutions- Be Creative.
